## 220.005 FEES FOR SERVICES BASED ON ABILITY TO PAY

220.005 (a) The fees for the following public health services will be offered to Lake County residents based on their ability to pay for such services. The fee will be established by using a sliding fee scale. The sliding fee scale is based on annual adjustments in the poverty income guidelines issued by the United States Department of Health and Human Services. (last revised 06/18/2012)

The following services are provided to Lake County residents on an ability to pay basis:

- (a) Section 220.21 Child Health Services (last revised 06/18/2012)
- (c) Section 220.60 Healthy Lifestyle Initiative (last revised 06/18/2012)

## 220.006 SLIDING FEE SCHEDULE

220.006 (a) Charges for those services delineated in section 220.005 will be in accordance with revised Child Support Agency Poverty guidelines published annually in the Federal Register. (last revised 06/18/2012)

220.006 (b) The Health Commissioner is hereby authorized to reduce the fees set forth in this subsection, at his or her discretion, in instances of financial hardship. The Lake County General Health District shall make all efforts to obtain additional funding to pay for such handling fees in the case of financial hardship.

## 220.01 PRIVATE WATER SUPPLY SYSTEM FEES.

Private water supply system fees are as follows:

- (a) New Installation Applications.
  - (1) Each application for a permit to install a private water supply system for a single-family dwelling shall be accompanied by a fee of one hundred seventy nine dollars (\$179). (last revised 12/18/2006)
  - (2) Each application for a permit to install a private water supply system for a non-single-family dwelling shall be accompanied by a fee of one hundred ninety six dollars (\$196.00). (last revised 12/18/2006)
- (b) New Installation Permits.
  - (1) The fee for each permit for the installation of a private water supply system for a single-family dwelling shall be one hundred ninety-six dollars (\$196.00). (last revised 12/18/2006)
  - (2) The fee for each permit for the installation of a private water supply system for a non-single-family dwelling shall be two hundred thirty two (\$232.00). (last revised 12/18/2006)
- (c) Alteration Applications.
  - (1) Each application for a permit for the alteration of a private water supply system for a single-family dwelling shall be accompanied by fee of thirty (\$30.00). (last revised 11/15/2004)
  - (2) Each application for a permit for the alteration of a private water supply system for a non-single-family dwelling shall be accompanied by a fee of thirty sixdollars (\$36.00). (last revised 11/15/2004)
- (d) Alteration Permits.
  - (1) The fee for each permit for the alteration of a private water supply system for a single-family dwelling shall be sixty dollars (\$60.00). (last revised 11/15/2004)

- (2) The fee for each permit for the alteration of private water supply system for a non-single-family dwelling shall be eighty four dollars (\$84.00). (last revised 11/15/2004)

(e) Sealing Applications

- (1) Each application for a permit to seal a private water supply system for a single-family dwelling shall be accompanied by a fee of thirty-nine dollars (\$39.00). (revised 03/01/2016)
- (2) Each application for a permit to seal a private water supply system for a non-single-family dwelling shall be accompanied by a fee of forty-six dollars (\$46.00). (revised 03/01/2016)

(f) Sealing Permits

- (1) The fee for each permit to seal a private water supply system for a single-family dwelling shall be seventy-eight dollars (\$78.00) (revised 03/01/2016)
- (2) The fee for each permit to seal a private water supply system for a non-single-family dwelling shall be ninety-one dollars (\$91.00). (revised 03/01/2016)

(g) Inspection, Water Sample Collection and Bacteriological Analysis.

- (1) A fee of forty-four dollars (\$44.00) shall be charged for each water sample collected for the purpose of bacteriological analysis for newly constructed and altered private water supply systems. (last revised 12/18/2006)
- (2) A fee of seventy dollars (\$70.00) shall be charged for the first sample in a series of samples, for the collection, inspection, bacteriological analysis, transportation and record maintenance of water samples collected from an existing private water supply system for one, two or three-family dwellings, except foster homes. A fee of sixty dollars (\$60.00) shall be charged for subsequent samples collected within a series for one, two or three-family homes, except foster homes. Where refunds are made to persons assessed fees through this regulation, a handling charge of thirty-five dollars (\$35.00) shall be withheld. (last revised 02/18/2008)
- (3) The fee for foster homes shall be twenty-five dollars (\$25.00) for each sample. (last revised 02/18/2008)
- (4) The fee for semipublic operations shall be seventy-five dollars (\$75.00) per sample. (last revised 02/18/2008)
- (5) A fee of seventy dollars (\$70.00), plus the fee currently assessed by the approved State Laboratory, shall be charged for samples collected for the purpose of chemical analysis. (last revised 11/15/2004)
- (6) The Health Commissioner is hereby authorized to reduce the fees set forth in this subsection, at his or her discretion, in instances where disease investigation, nuisance investigation or financial hardship is involved or when another governmental agency requests the inspection and water sample.

(h) 220.01 (h) PWS Variance

The fee for a variance request to be issued under OAC 3701-28-21 shall be ten dollars (\$10) (last revised 01/22/2007)

(i) Transportation Equipment.

All transportation equipment used in distribution of water, including, but not limited to, tank trucks, tank cars and tank wagons, shall be charged an annual inspection fee of one hundred dollars (\$100.00). (last revised 01/20/2009)

(j) A penalty of one hundred percent (100%) of the permit fee outlined in sections 220.01 (b, d and f) shall be assessed if the installation, alteration, or sealing of a private water system has commenced prior to permit issuance. This additional fee shall not be charged for an emergency alteration performed in compliance with Ohio Administrative Section 3701-28-03 (H). (last revised 11/20/2000)

(k) Registered Contractor Inspections as per OAC 3701-28-04(F)  
(1) New Wells--\$200.00 (enacted 3/17/14)  
(2) Sealing--\$200.00 (enacted 3/17/14)  
(3) PWS Pump, Casing and/or Pitless Adapters--\$100.00 (enacted 3/17/14)

(a) The fee for a certified copy of a vital record or for a certification of birth shall be twenty-three dollars (\$23.00). (last revised 07/01/2025)

(d) The local fee for a burial permit for a death which occurred out of in county shall be fifty cents (\$0.50). (Effective 10/22/2025)

(e) The fee for a birth or death listing shall be five dollars (\$5.00) for each month requested.

#### 220.51 MISCELLANEOUS FEES

Miscellaneous fees are as follows:

- (a) The fee for copies made using Lake County General Health District's equipment shall be equal to the cost incurred in making such copies.

#### 220.60 MISCELLANEOUS PUBLIC HEALTH FEES

The Health Commissioner is hereby authorized to reduce the fees set forth in this subsection, at his or her discretion, in instances of financial hardship. The Lake County General Health District shall make all efforts to obtain additional funding to pay for such handling fees in the case of financial hardship. (last revised 05/17/2010)

- (a) Drug Assistance Program (last revised 05/17/2010)

The Board of Health of the Lake County General Health District shall enact a Drug Assistance Program Administrative Fee based on a Service Contract cost with a Non Profit agency working in association with or designated by a pharmacy based DRP, a hospital or non-profit clinic at the discretion of the Health Commissioner. Any such DRP must agree to provide pharmaceutical drugs in accordance with the Laws and Rules delineated in Ohio Revised and Ohio Administrative Code to those identified by Lake County General Health District to be eligible for the program. For the purpose of accessing a DRP, Program as defined and updated by OAC 4729-35-05, the monthly Administrative Fee shall be in accordance with the following formula and be determined annually in January of each year:

$$\frac{\text{Service Contract Cost/ Number of Average Monthly Participants}}{\text{Number of Months in the Contract}}$$

(b) Healthy Lifestyles

The fee for services will be at the rate of \$50.00 per hour. (last revised 08/15/2011)

220.61 Mosquito Yard Spray Fees

- (a) The fee for yard spray service shall be \$80.00 for a residential lot less than 1/3 acre in size. (last revised 05/15/2000)
